Dear Constituent,

Thank you for your inquiry. The Florida Department of State, Division of Historical Resources administers a program of historic preservation grants. Our statutory authority for the program is contained in Chapter 267.0617, Florida Statutes. One of the principal types of grants we award is for appropriate restoration/rehabilitation of historic buildings. However, eligible applicants must be either units of Florida state/local governments or not-for-profit organizations. Typically, the restoration project is being undertaken so that the building can continue in some type of public use. At this time, our program does not award grants to private individuals or entities. The following are other programs that might be of assistance:

- 1) While the Florida Division of Historical Resources preservation grants program does not extend to privately-owned properties, the Division does administer, along with the National Park Service, the Federal Rehabilitation Tax Credit program. This program provides a 20% income tax credit (based on the cost of rehabilitation) for a "certified historic rehabilitation" of a "certified historic building." It is for *income-producing* properties that are listed, or eligible for listing, on the National Register of Historic Places at the time of rehabilitation and whose rehabilitation meets the Secretary of the Interior's Standards for the Treatment of Historic Properties, which can be found here: <a href="https://www.nps.gov/tps/standards.htm">https://www.nps.gov/tps/standards.htm</a>. - 2) Section 196.1997, Florida Statutes, allows local governments to grant ad valorem tax exemptions for the restoration of historic properties, including private residences. To inquire about such local tax incentives that may be available, contact your city and county planning departments for information.
- 3) An additional option may be financing the property through the U.S. Department of Housing and Urban Development's FHA 203(k) program. Participating lenders can provide a mortgage that includes both the cost of rehabilitation and purchase of the property. - 4) Another alternative may be financing the improvement through the U. S. Department of Housing and Urban Development's Property Improvement Loan Insurance (Title I).
