ANNUAL REPORT 2019 - 2020

Dear colleagues and friends,

What can I say about 2019-2020, a year when so many people and organizations in Florida's arts and culture community found themselves faced with choices no one ever expected to have to make?

Advancing, supporting, and promoting arts and culture is the mission of the Florida Division of Cultural Affairs. I'm proud to say that we have worked hard this year to achieve those goals.

We launched our 2020-2025 Strategic Plan in January 2020. This plan focuses on three key strategic issues:

- Working Better Together: How can DCA foster and create broader connections, collaborations and partnerships more effectively?
- Visibility/Awareness: How can DCA increase visibility and awareness of Florida's arts and culture to advance DCA's mission?
- Diversity/Equity/Inclusion: How can DCA foster a culture of diversity, equity and inclusion within the arts and culture community?

Our activities during 2019-2020 directly relate to these issues. We gathered 24 artists from across Florida to learn skills including strategic planning and promoting their work at our Professional Development for Artists workshop hosted by Bay Arts Alliance in Panama City. As part of the Division's response to the impact of Hurricane Michael on local artists, this workshop included new content on disaster preparedness and resources for artists across all disciplines. The Creating Healthy Communities: Arts + Public Health in Florida conference, presented in partnership with the University of Florida Center for Arts in Medicine, United Arts of Central Florida and ArtPlace America, hosted by the Pabst Steinmetz Foundation and the Dr. Phillips Center for the Performing Arts, connected people working and thinking at the intersections of the arts, public health and community development with the overarching goal of creating stronger and healthier communities through the arts.

Our Grantmaking Task Force comprising leaders from the field began working in January to create recommendations for improving our grantmaking structure. The purpose of this assessment is to create more accessible pathways through the application process, refining the funding process and developing ways to reach underserved areas of the state.

2019-2020 was a milestone year for the DCA. Established in 1969 by the Florida Legislature under the Department of State, the Division of Cultural Affairs has supported and promoted Florida's diverse arts and culture community for 50 years. During that time, DCA has distributed more than \$787 million to every corner of the state. In honor of this milestone, a reception at the John and Mable Ringling Museum of Art hosted by the Arts and Cultural Alliance of Sarasota County welcomed members of the Florida Council on Arts and Culture, arts and culture organizations from across the state, elected officials, Secretary of State Laurel M. Lee and Division staff to celebrate half a century of Florida's state arts agency. Attendees were treated to entertainment from West Coast Black Theatre Troupe and Sarasota County's Emanne Beasha, the 12-year-old operatic soprano star of America's Got Talent. Our 50th Anniversary also saw the publication of 50 Stories for 50 Years, a booklet celebrating the stories of 50 grantees across the Division's first five decades.


